Production orders created from the PRD module include the quantity, variant, bill of materials components and route operations of the product. While the creation of a production order, the missing items analysis is performed automatically. With the help of detailed planning types, this module provides the possibility of forward or backward scheduling and allows operations to be rescheduled. It can also obtain information about resources and the usage of the resources. It is also possible to compare planned/ actualized production levels, input quantities and production quantities on the module.
